



## 2018 Dana Winkler Scholarship Program

College is expensive and the competition for scholarships can be challenging. We want to help. We've created the easiest possible scholarship program, with a substantial award, exclusively for Wichita Federal Credit Union members.

### Scholarship Awards

Wichita Federal Credit Union (WFCU) will award up to eight (8), \$1,000 scholarships to qualifying students and their accredited educational institutions.

### Eligibility

Applicants must meet the following criteria prior to applying for a scholarship:

- Must be a current member of WFCU for a minimum of twelve (12) months, and account must be in good standing. Must be between 15-25 years of age, and either a graduating high school senior or full-time undergraduate college student enrolled in a post-secondary school.
- Must have at least a 3.0 grade point average.
- Previous recipients of the Dana Winkler Scholarship should note that you cannot receive this scholarship more than twice in succession. For example, if you were awarded a scholarship in 2016 and 2017, you are not eligible for the 2018 award. However, you are encouraged to apply again in 2019.
- Submit the completed WFCU application, signed consent form, a listing of scholastic awards/honors, extra-curricular activities/awards, community service, college career plans and career goals, and an essay of at least 500 words, answering the following two part question with specific examples:

**What does financial health mean to you? How will you use your knowledge of financial health in your career choice – and what do you see as the role of this Credit Union?**

*Employees of WFCU, Directors, Volunteers, and their immediate families are not eligible to participate.*



## Application Process

Eligible members have three options for obtaining an application:

- 1) **Online-** at [wichitafcu.com](http://wichitafcu.com) under "Services"
- 2) **Call-** 316.558.9504 to request an application to be mailed or e-mailed
- 3) **Come by-** Any WFCU location for an application

Upon completion, the application and required documents must be submitted in their entirety electronically - one of 2 ways:

Submissions are time stamped, and will not be accepted after the deadline.

## Selection Process

The volunteers of the Scholarship Committee review scholarship applications and determine scholarship recipients. Judging is based upon subjective criteria including dedication to academics, extracurricular activities, community involvement, personal goals and essay question responses.

The Scholarship Committee may deem it necessary to interview the top scholarship applicants. If interviews are held, applicants will be contacted by phone or e-mail as to the date, location and time of the interview. All applicants will be notified in May, 2018 via a phone call, email, and/or a letter. Please be sure all contact information is accurate and up to date on the application.

## Additional Information

All submissions are due on or before **April 1, 2018, by 11:59pm CST.** Incomplete or late submissions will not be accepted. Submissions will not be returned to participants.

Scholarship recipients will be asked to submit their photograph in May, 2018 which may be used in publicizing Wichita Federal Credit Union's scholarship program. Do not send a photograph with the application. Checks will be issued to both the scholarship recipient and the recipients' school. Recipients and their parent(s) will receive an invitation to attend the awards dinner hosted by the Scholarship Committee for the presentation of the scholarship award certificate and check. ## About Mr. Dana Winkler

Mr. Winkler has been a member of Wichita Federal Credit Union since 1979. From 1979 until 2012, he served as the credit union director. He was the Chairman of the Board in both 1982 and 1999, and served on various committees, including the Scholarship Committee. Additionally, he volunteered for 5 years on the Wichita Public Schools Special Education Advisory Council and worked with the parents' organizations for hearing impaired and gifted students to better the services available to special education students.

Mr. Winkler also served his country. He is a Vietnam Veteran, and dedicated 30 years in the Army Reserves, retiring as a Full Colonel in 1997.

In 2012, a unanimous decision was made by the Board of Directors to name the WFCU Scholarship Program after Dana as a tribute to him for his dedicated service to the Board and our members, for over 30 years.

Dana was an attorney for the City of Wichita, having earned a law degree at Washburn University School of Law. He retired from the City Law Department after 22 years of service. Currently he is an attorney for the Sedgwick County District Court, as a Guardian ad litem. In this capacity he represents the best interest of children who are involved with the court and children in need of care.

The Dana Winkler Scholarship exemplifies excellence, perseverance, dedication and service to the community, as does Mr. Dana Winkler.

WFCU began awarding scholarships in 2004 to reward and encourage young members as they pursue post-secondary education. As of 2017, we are proud to have invested over \$87,000 in scholarships and young members in our community, ensuring the gift of knowledge to tomorrow's leaders.
